OPEN LETTER TO CONGRESSMAN JIM JORDAN

April 30, 2022

Dear Congressman Jordan:

I have long admired you for refusing to cater to the Leftists and Republican RINOs, as the creator of the Freedom Cause and a recipient of the President's Medal of Honor and as a defender of our Constitution in Congress. However, the vast majority of the American people agree that Congress is not doing their job. The truth is that certain executive policy decisions and certain congressional policy decision are being made by the chief justice at the US Judicial Conference with Congress's knowledge and consent. This robs the American people of their freedom. In fact, it is the leading cause of all of our great nation's ills. This is the cause of America's problems, not its people, and certainly not the glorious and wise Declaration of Independence, US Constitution and Bill of Rights. America's Manifest Destiny" is liberty and dirty deals between Congress and judges is tyranny.

Respectfully sir, your stance on my proposed legislation – the Eva Asensio Anti-Judicial Corruption Act of 2023 – needed to be publicly and formalized announced and debated between us in the public arena *before* you endorsed my opponent, Kat Cammack. Your endorsement without disclosing your position and reasoning, and debating my Bill is not good for America and does not honor your political position.

I know that Kevin McCarthy is concerned about my firm moral and political stance against his decision to side with Congresswoman Alexandria Ocasio-Cortez and against Congressman Ted Yoho. But this is Kat Cammack's concern and should not be your issue. On the contrary, it guarantees that I [like you] would oppose McCarthy if he decided to run to be the leader of the Republicans in the House.

My Bill *cleanly* fixes the *plain* mistakes that Congress made in drafting its 42-year-old "Judicial Conduct Act." These provide the chief justice the opportunity to marshal federal *and state* judicial corruption into an unconstitutional and undemocratic executive and legislative power. In the



Judicial Conduct Act Congress mistakenly transferred Constitution's Take Care of Law authority from the president and Congress's legislative power to the chief justice.

As I have explained to Kat Cammack, without my Bill the Judicial Conduct Act is anti-natural rights, anti-family and parental rights, anti-presumption of innocence, anti-equal protection, anti-due process [anti right to a jury, charges based on neutral principles, and anti-the-absolute-limits on the power of judges], anti-border security, anti-separation of powers, and anti-separation of church and state. This makes the Judicial Conduct Act as it exists anti-rule of law, undemocratic and unconstitutional.

As I mentioned in my opening, you work in Congress. On the other hand, I have experience defending the Constitution directly against its greatest foe. I did my work preparing to enter political against a state governor and state chief judge, and against Chief Justice John G. Roberts, Jr. at the US Judicial Conference under Judicial Conduct Act. This is how I discovered fatal mistakes Congress made in the Judicial Conduct Act and why I created the Institute of Judicial Conduct that is:

1. the nation's only known independent authority on federal judiciary policy, the legal and regulatory status of federal judicial misconduct in US courts and the US Judicial Conference, and the only authority that has identified the mistakes Congress made in the Judicial Conduct Act of 1980;
2. the nation's leading authority on the legal and regulatory on the questions of fact and law related to the constitutionality or unconstitutionality of the results of the 2020 election's process and results, and former vice president, Mike Pence's certification.

You cannot deny that my case is right on the bull's eye. In the summer 2020 I wrote and produced a graphic novel based on my real-life experiences titled "*Trump Unites ALL American!*" that stars my daughter, Eva Asensio, and President Trump, co-starring his former US Attorney General Bill Barr, and Roberts. Barr and Roberts are joined in the proceedings at the US Judicial Conference and have been advised on my story. It explains how federal judicial corruption is used to abrogate American's unalienable civil rights (presumption of innocence, due process, and equal protection) to get at their most precious natural rights - under the false flag of advancing society.

Any analysis of the 2020 election must include a determination of federal judicial conduct towards President Donald J Trump. My Bill represents the Republican Party's only direct and bona fide response to federal judicial corruption and how this affected the constitutionality or unconstitutionality of the results of the 2020 election's process and results, and Pence's certification.



I am now running for Congress to apply knowledge and information I have acquired to help Republicans achieve their goal of not just defending Constitution but reversing its destruction and restoring Bill of Rights, truth, and justice to their rightful place in America.

I discovered the This is how the Leftists and Republican RINO worked with against President Trump throughout his administration and in the post-election process. – fixes the mistakes Congress made and shows that Roberts is the invisible hand disturbing everything and everyone in our civil society. My work shows Roberts as the culprit who rigged the 2020 election by labeling Trump and his immigration policies racist going so far as personally executing a dirty scheme to prevent Trump from reinstating a citizen question on the 2020 Census, which Obama had removed.
