



## THIRDTEENTH OPEN LETTER TO CONGRESSWOMAN KATHRYN CAMMACK

October 30, 2022 -Second Version.

Dear Congresswoman Cammack:

Thank you for making your appearance this past week in my civil action against you under the Florida Racketeer Influenced and Corrupt Organization (RICO) Act. You had been evading service since August 9, 2022. I trust you will be more respectful of your oath to the US Constitution and official duties in the future as we move through the process to your deposition.

I note that you have appointed your chief of staff, Larry Calhoun, as the person responsible for receiving on your behalf documents filed in my RICO action against you. Mr. Calhoun and I are well-acquainted. He is central to the case. He and I had a productive meeting after last year's Black Tie and Blue Jeans Dinner. The meeting ended at my home in the early hours of the following day.

The focus of our meeting was the content of the record I created in the 117th Congressional record concerning my consideration filed under the US Judicial Conduct Act at the US Judicial Conference that is administered by the Administrative Office of the US Courts. I trust that Mr. Calhoun has shared the information contained in this record with you and briefed you on our meeting. For your convenience, I have attached a copy of this record's docket listed by subject matter, the respective executive, congressional, and judicial offices and individuals outside of the federal government. These include a letter President Joe Biden when he was a presidential candidate. The one to Congresswoman Alexandria Ocasio-Cortez (AOC) is central to our issues.

I explicitly explained to Mr. Calhoun that this record forms the foundation for the two laws I planned to introduced. Mr. Calhoun's role is also important because he has received on your behalf all forty-seven open letters that I have published thus far in my political campaign. This is the thirteenth of these letters addressed to you. Also please find attached a copy of my



first open letter to you and a copy of my first open letter directed to AOC, which established the foundation for my first open letter to you.

The open letters record holds information of your lies and your schemes to harm me, misrepresent my legislative agenda, and to cancel information about you being not just a [liar](#), a political conformist, and an opportunist becoming known to voters in the Republican primary.

Your AOC fraud got you into Congress. Correcting that great wrong and using AOC, a celebrity enemy of America and the US Constitution, to highlight the urgent need to enact for my laws is the reason I chose to run against you. I was ready. I gave notice to the GOP leaders of the Republican Party of Alachua County in July 2020 that I would run against you if you won the primary. We spoke about the AOC-Ted Yoho scandal.

After I met with Mr. Calhoun, I met with Justin Waters at my home. At the time I did not know that Mr. Waters was your bought-and-paid-for patsy. I could never have imagined that you and Mr. Waters would collude to spread the lie that I was a liberal spy from New York City posing as a constitutional conservative and then hide from debate for a full year and fabricate a legal filing without notice right before the election season began to bolster this false narrative.

Not only are you a liar who colluded with Mr. Waters, but you concocted a fraud to get President Donald J. Trump's endorsement. Attached is my open letter to you dated April 12, 2022 presenting you with questions about President Trump's endorsement. After you ignored my questions I discerned the truth through other means and found out that you obtained [Trump's endorsement fraudulently](#).

Conservative voters have a right to know the facts that show them who is a conservative, who is an opportunist, who has the policies and a plan to deal with the corruption of the US Constitution by the US federal government, and who is corrupt and in politics for the money.

You evaded debate and dialogue between us for two years. Freedom of Speech is the only way to discover which of us is ready, willing, and able to fight back and win against the Left's great lies



about the US Constitution or which of us is a conformist and opportunist seeking personal gain and self-aggrandizement at the expense of American liberty and freedom.

The plain truth is that you colluded with Justin Waters to cancel me because publicly opposing me and my bills would be political suicide in Florida's Third Congressional District.

Doing this would reveal the fact that you are a tool for the other Republican conformists and opportunists in Congress who help the Left advance its absurdities, political nonsense, and legal schemes - like lying about the true inflation rate and printing money to avoid raising taxes to hide real expenditures and to use printed money to keep interested down below the real inflation rate. This steals from families on both the income and cost sides.

These are the Left's WOKE communistic fiscal and monetary policies that fuel their corruption that my laws end. I have been and am always ready, willing, and able to meet and openly cooperate with you.

Thank you, and God Bless America.

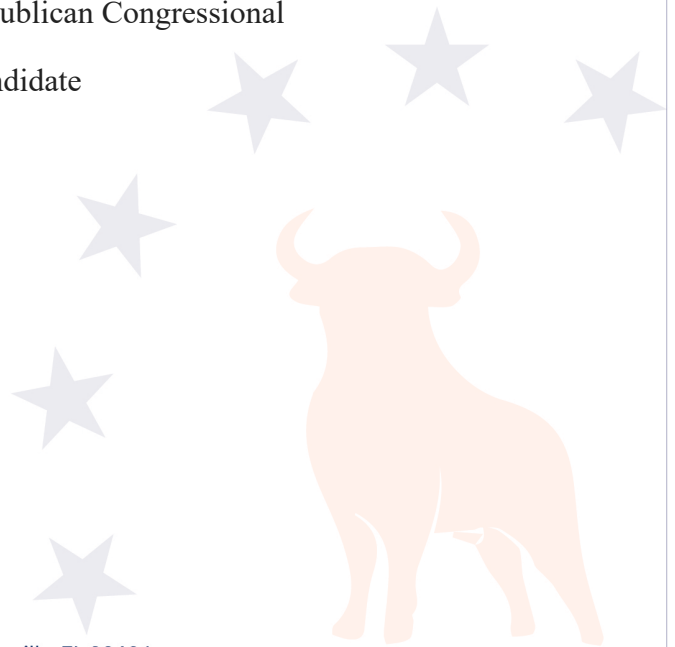

## AN OPEN LETTER TO CONGRESSWOMAN KATHRYN CAMMACK

November 17, 2021

Dear Congresswoman Kat Cammack,

## AN OPEN LETTER TO ALEXANDRIA OCASIO-CORTEZ

**OPEN LETTER DEMANDING INFORMATION ON KAT CAMMACK DISCLOSURE TO  
PRESIDENT TRUMP ABOUT THE PRIMARY CONTEST IN FLORIDA'S 3<sup>RD</sup>  
CONGRESSIONAL DISTRICT**

Dear Kat:

This letter is a follow-up to the numerous attempts I have made to discern the significance of the video you made and posted on Facebook on April 6, 2022, titled "Big News! Just hung up with President Trump! Here is what he had to say . . . Spoiler alert . . . He's endorsing our re-election campaign!"

You have seen my proposed litigation in draft and final form titled "The Eva Asensio Anti-Judicial Corruption Act of 2023 (Act)" and my First Amendment to Consideration of the Domestic Relations and Domestic Violence Exemption at the US Judicial Conference. These are central to any review of the legal and regulatory status of abortion and parenting rights, and the 2020 election or former Vice President Mike Pence's role in certifying the electoral votes.

Did you advise President Trump that you have refused to disclose your position on any of these matters and the Eva Asensio legislation?

The video is over 4 minutes long but contains no information about President Trump's knowledge or opinions about the history of controversies between us, the stark differences in our policies on all matters related to the Constitution, its doctrines, values, and principles, and the policies of the America First and Trump Movement, and the basis for my assertion that your political ideologies translate to anti-Trump positions.

You are hiding our issues from the public arena.

You have refused to address our important policy differences. You have worked to keep information about our arguments from the public, the press, and the voters. You are concealing the history of our dealings and why I am running against you.
